**SECTION-3**

**HAZARD IDENTIFICATION**

Causes eye and skin irritation. Inhalation can cause irritation to the respiratory tract and can result in chemical pneumonitis if aspirated. ## SECTION-4 FIRST AID MEASURES

- General Advice : In case of accident or unwellness, seek medical advice immediately (show directions for use or safety data sheet if possible).

- If ingestion : Do NOT induce vomiting. Rinse mouth. Drink plenty of water. If symptoms persist, call a physician.

- Suitable extinguishing media : Use extinguishing measures that are appropriate to local circumstances and the surrounding environment
- Specific hazards arising : No specific hazard known.

## SECTION-6 ACCIDENTAL RELEASE MEASURES

- Personal precautions, protective equipment and emergency procedures : In case of spillage it is important to take all steps necessary to: Avoid contact with the spilled material or contaminated surfaces.  
Extinguish or remove any sources of ignition. When dealing with spills do not eat, drink or smoke and wear protective clothing and equipment. Keep people and animals away. Prevent spilled material

Collect and store in properly labelled, sealed drums for safe disposal. Deal with all spillages immediately). Take up mechanically, placing in appropriate containers for disposal. Clean contaminated floors and objects thoroughly, observing environmental regulations If contamination of drains, streams, watercourses, etc. is unavoidable, warn the local water authority.

- Precautions for safe handling : Safe work practices are recommended. Avoid contact with eyes and skin.
- When opening the container and preparing spray wear appropriate PPE (refer Section 8).
- Do not spray under high wind conditions.
- Conditions for safe storage : Keep out of reach of children, unauthorized persons and animals.
- Store in tightly sealed original containers in a dry secure place away from fertilizers, feed and food.
- Incompatibilities : Store out of direct sunlight and extreme temperature.
