# **ACCIDENTAL RELEASE MEASURES**

In case of spillage it is important to take all steps necessary to: Avoid contact with the spilled material or contaminated surfaces. Extinguish or remove any sources of ignition. When dealing with spills do not eat, drink or smoke and wear protective clothing and equipment. Keep people and animals away. Prevent spilled material from entering drains or watercourses.



Environmental precautions

Do not allow to get into surface water, drains and ground water. If the product contaminates rivers and lakes or drains inform respective authorities.

Reposition any leaking containers so as to minimize leakage. Dam and absorb spill with an absorbent material (eg. sand or soil). Shovel the absorbed spill into drums

Take up mechanically, placing in appropriate containers for disposal.
