SECTION-4

FIRST AID MEASURES

SECTION-6

ACCIDENTAL RELEASE MEASURES

- Personal precautions, protective equipment and emergency procedures : In case of spillage it is important to take all steps necessary to: Avoid contact with the spilled material or contaminated surfaces.
- Extinguish or remove any sources of ignition. When dealing with spills do not eat, drink or smoke and wear protective clothing and equipment. Keep people and animals away. Prevent spilled material from entering drains or watercourses.

- Reposition any leaking containers so as to minimize leakage. Dam and absorb spill with an absorbent material (eg. sand or soil). Shovel the absorbed spill into drums

Collect and store in properly labelled, sealed drums for safe disposal. Deal with all spillages immediately). Take up mechanically, placing in appropriate containers for disposal. Clean contaminated floors and objects thoroughly, observing environmental regulations If contamination of drains, streams, watercourses, etc. is unavoidable, warn the local water authority.

HANDLING AND STORAGE

- Precautions for safe handling : Safe work practices are recommended. Avoid contact with eyes and skin.

- Do not spray under high wind conditions.
- Conditions for safe storage : Keep out of reach of children, unauthorized persons and animals.
- Store in tightly sealed original containers in a dry secure place away from fertilizers, feed and food.
