SECTION-4

FIRST AID MEASURES

SECTION-6

ACCIDENTAL RELEASE MEASURES

- Personal precautions, protective equipment : In case of spillage, it is important to take all steps necessary to: Avoid contact with the spilled material or contaminated surfaces.

- and emergency procedures : Extinguish or remove any sources of ignition. When dealing with spills do not eat, drink or smoke and wear protective clothing and equipment. Keep people and animals away. Prevent spilled material from string drains or watercourses.

HANDLING AND STORAGE

- Precautions for safe handling : Safe work practices are recommended. Avoid contact with eyes and skin. When opening the container and preparing spray wear appropriate PPE (refer Section 8). Do not spray under high wind conditions.
- Conditions for safe storage : Keep out of reach of children, unauthorized persons and animals.
Store in tightly sealed original containers in a dry secure place away from fertilizers, feed and food.
- Incompatibilities : Store out of direct sunlight and extreme temperature.
